Over the past few months, our library system has taken steps to comply with changes in the state and local laws:

- The Rutherford County Library System (RCLS) is governed by our Board of Directors, an 11-member board whose representatives are appointed by each of our funding bodies based population (U.S. Census) as directed by the State of Tennessee. The Board is comprised of
 - o4 representatives appointed by Rutherford County
 - o4 representatives appointed by the City of Murfreesboro (one is a council member)
 - 2 representatives appointed by the Town of Smyrna (one is a town council member)
 - o1 representative appointed by the City of Eagleville
 - Board members are volunteers who can serve two consecutive 3-year terms.
- Our system receives funding from all four governmental entities listed above; RCLS is governed by the Board of Directors.
- Here are some statistics on our library system for 2022/23:
 - oln **2022/23**, the total budget for the Rutherford County Library System [RCLS] was \$4,074,588
 - RCLS contains 209,049 items and services a population of 313,091 (LaVergne has their own library that is a department of the city)
 - ∘ 1,245,566 items were checked out on the Bookmobile and at Eagleville, Linebaugh, HRC, MGL, Smyrna and TEC libraries
 - o449,537 e-audio/e-books/digital magazines were downloaded over the past year
 - oRCLS had 633,753 visits to our six locations
 - o 73,460 active library cardholders system-wide
 - o Librarians answered 43,931 reference questions
 - oPatrons used computers 192,362 times over the past year
 - Program attendance was 59,458

- Book titles withdrawn may still be available on digital platforms, as the RCLS has no control over those databases.
- All requests are considered individually, and staff recommendations are presented to the Board of Directors for a final decision.
- In considering each book, the staff and board are obligated to follow state and local laws

 - A Murfreesboro decency ordinance was passed in June 2023. City Council unanimously voted to repeal the decency ordinance on January 11, 2024.
- Decisions about individual books are not focused on any particular group; RCLS is here to serve all residents of Rutherford County.

- In an effort to further address local and state laws, the board voted in August 2023 to approve a graduated library card system which will be implemented beginning December 18, 2023. By default, children (birth through age 12) and young adults (ages 13-17) will be limited to their own sections.
